Fish Limits

Fish size: 14 inches and over

Each Team is allowed to weigh-in a limit of five (5) fish, per day. Culling of a dead fish is not allowed.

Any fish presented for weigh-in which fails to measure the official length limits shall accrue penalties at the rate of one (1) pound for each non-legal fish plus loss of the fish.

A 8 ounce penalty for each dead Bass presented for weigh-in. Culling of dead bass is prohibited. No dead bass will be eligible for Big Bass awards or prizes.

Required Safety Equipment

It is the responsibility of all anglers to have required state and federal safety equipment on board.

At time of inspection each morning, be prepared to display 1 chest type life jacket worn by each angler; 1 throwable PFD; and, demonstrate functioning kill switch.

Inspection will be held as boats are released during takeoff. Live wells must be empty.

Boundaries Off limits from the buoys in at start cove. See off limits map at registration on Friday.

The tournament waters for this event is shall be Lake Sam Rayburn. Contestants may fish anywhere on tournament waters accessible by boat, except areas designated as "off limits", "no boats", "keep out", "restricted" or "no fishing" (or similar language or markings intended to restrict public access) by state or federal officials or within 50 yards of a competitor's boat which was first anchored. See rule #15 for anchored definition. Any additional off limits will be announced at Friday night registration. Only water open to all public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to contestants. All local, state and federal regulations apply.

<u>Contingency Programs</u> – For All Teams. If you think you might be eligible for a Ranger, Nitro or Triton boat contingency you MUST have your Boat HIN # with you before you come to Pre-Tournament Check-in on Friday evening.
