<u>Registration/On-site Check-in</u>	<u>Launch Location:</u> Catfish Bay Marina, 11586 Rooster Creek Dr. Kingston, OK 73439 <u>Weigh in LOCATION:</u> West Bay Casino & Resort 11840 State Park Rd. Kingston, OK 73439 Saturday, April 25, 2026 Take-off begins at 7:00am. or first safe light. Be in water ready to take off by 6:30am Weigh-in begins at 3:00pm.	<u>Required Safety Equipment</u> It is the responsibility of all anglers to have required state and federal safety equipment on board. At time of inspection each morning, be prepared to display 1 chest type life jacket worn by each angler; 1 throwable PFD; and, demonstrate functioning kill switch. Inspection will be held as boats are released during takeoff. Live wells must be empty.
Fish Limits Fish size: 14 inches and over Each Team is allowed to weigh-in a limit of five (5) fish, per day. Culling of a dead fish is not allowed. Any fish presented for weigh-in which fails to measure the official length limits shall accrue penalties at the rate of one (1) pound for each non-legal fish plus loss of the fish. A 8-ounce penalty for each dead Bass presented for weigh-in. Culling of dead bass is prohibited. No dead bass will be eligible for Big Bass awards or prizes.	<u>Allowed Practice Date ONLY for Pre-registered teams -</u> PLEASE READ THE RULES CAREFULLY! - Membership & Entry Fees MUST be paid before launching to pre-fish on any allowed designated practice day, per the rule #6. Lake Texoma - Off-limits: 04/20-04/24 Allowed practiced day for pre-registered teams ONLY 04/24	Boundaries See off limits map at registration on Friday. Catfish Bay Marina is off-limits to fishing from the no wake buoy's in. The tournament waters for this event shall be Lake Texoma. Contestants may fish anywhere on tournament waters accessible by boat, except areas designated as "off limits", "no boats", "keep out", "restricted" or "no fishing" (or similar language or markings intended to restrict public access) by state or federal officials or within 50 yards of a competitor's boat which was first anchored. See rule #15 for anchored definition. Any additional off limits will be announced at Friday night registration. Only water open to all public fishing will be considered tournament waters. Any waters closed to public fishing will be closed to contestants. All local, state and federal regulations apply
